In the meantime, I include in the packet for background the applicable section of 1 VSA \$313, as well as the applicable section(s) of Barre City Council Rules of Procedure for Public Bodies of the City of Barre.

Barre City's **Rules of Procedure for Public Bodies** defines a "public officer" as: Public officer or public official means a person elected or appointed to perform executive, administrative, legislative, or quasijudicial functions for the City of Barre. Persons elected or appointed must be legally able to hold the position

It appears to both City Clerk Carol Dawes and me that Council is considering the appointment of volunteer to a committee/work group/task force to be equivalent to the appointment of a "public officer" as referenced above.

While neither Carol nor I claim to be legal professionals, it appears in our lay judgement that the "Public Official or employee" phrase of 1 **VSA \$313.a** (3) the discussion of such <u>volunteer appointments</u> is not allowed under the Executive Session exclusion of the Open Meeting Law.

However, I will await the opinion of the VLCT Staff Attorney

The Vermont Statutes Online

Title 1: General Provisions

Chapter 005: Common Law; General Rights

Subchapter 002 : Public Information

(Cite as: 1 V.S.A. § 313)

§ 313. Executive sessions

- (a) No public body may hold an executive session from which the public is excluded, except by the affirmative vote of two-thirds of its members present in the case of any public body of State government or of a majority of its members present in the case of any public body of a municipality or other political subdivision. A motion to go into executive session shall indicate the nature of the business of the executive session, and no other matter may be considered in the executive session. Such vote shall be taken in the course of an open meeting and the result of the vote recorded in the minutes. No formal or binding action shall be taken in executive session except for actions relating to the securing of real estate options under subdivision (2) of this subsection. Minutes of an executive session need not be taken, but if they are, the minutes shall, notwithstanding subsection 312(b) of this title, be exempt from public copying and inspection under the Public Records Act. A public body may not hold an executive session except to consider one or more of the following:
- (1) after making a specific finding that premature general public knowledge would clearly place the public body or a person involved at a substantial disadvantage:
 - (A) contracts;
 - (B) labor relations agreements with employees;
 - (C) arbitration or mediation;
 - (D) grievances, other than tax grievances;
- (E) pending or probable civil litigation or a prosecution, to which the public body is or may be a party;
- (F) confidential attorney-client communications made for the purpose of providing professional legal services to the body;
 - (2) the negotiating or securing of real estate purchase or lease options;
- (3) the appointment or employment or evaluation of a public officer or employee, provided that the public body shall make a final decision to hire or appoint a public

officer or employee in an open meeting and shall explain the reasons for its final decision during the open meeting;

- (4) a disciplinary or dismissal action against a public officer or employee; but nothing in this subsection shall be construed to impair the right of such officer or employee to a public hearing if formal charges are brought;
 - (5) a clear and imminent peril to the public safety;
- (6) records exempt from the access to public records provisions of section 316 of this title; provided, however, that discussion of the exempt record shall not itself permit an extension of the executive session to the general subject to which the record pertains;
 - (7) the academic records or suspension or discipline of students;
- (8) testimony from a person in a parole proceeding conducted by the Parole Board if public disclosure of the identity of the person could result in physical or other harm to the person;
- (9) information relating to a pharmaceutical rebate or to supplemental rebate agreements, which is protected from disclosure by federal law or the terms and conditions required by the Centers for Medicare and Medicaid Services as a condition of rebate authorization under the Medicaid program, considered pursuant to 33 V.S.A. §§ 1998(f)(2) and 2002(c);
- (10) security or emergency response measures, the disclosure of which could jeopardize public safety.
- (b) Attendance in executive session shall be limited to members of the public body, and, in the discretion of the public body, its staff, clerical assistants and legal counsel, and persons who are subjects of the discussion or whose information is needed.
- (c) The Senate and House of Representatives, in exercising the power to make their own rules conferred by Chapter II of the Vermont Constitution, shall be governed by the provisions of this section in regulating the admission of the public as provided in Chapter II, § 8 of the Constitution. CITY OF BARRE, VERMONT

RULES OF PROCEDURE for PUBLIC BODIES OF THE CITY OF BARRE

A. Purpose.

The Barre City Council, and all current and future public bodies, are required by law to conduct its meetings in accordance with the Vermont Open Meeting Law. 1 V.S.A. §§ 310-314. Meetings of the Barre City Council and all current and future public bodies must always be open to the public, except as provided in 1 V.S.A. § 313.

B. Application.

This policy shall apply to all regular, special, and emergency meetings of public bodies of the City of Barre City. Nothing in this policy shall preclude the ability of public bodies to adopt additional rules as required by law (i.e. Board of Civil Authority 24 V.S.A. § 101-6, Board of Abatement 24 V.S.A. § 1533, Planning Commission 24 V.S.A. § 4323, Development Review Board 24 V.S.A. § 4461).

C. Definitions.

For the purposes of this policy, the following definitions shall apply:

Advisory Group means a group appointed to provide input or recommendations offered as a guide to topic-specific action to City Staff or designee. Solicitation and appointment are made by the City Manager or a designee of the City Manager.

Board means an official group of persons who direct or supervise some activity provided by Legislative or municipal mandate.

Council means the City Councilors and Mayor for the City of Barre.

Commission means a group of persons authoritatively charged with particular functions. Solicitation and appointment are made by the Council.

Committee means a person or group of persons elected or appointed to perform some service or function, as to investigate, report on, or act upon a particular matter. Solicitation, direction, and appointment are made by the Council.

Public body means any current or future advisory group, board, council, commission, or committee of the City of Barre. Teams and Work groups are not considered public bodies.

Public interest means an interest of the community as a whole, conferred generally upon all residents of the City of Barre.

Public officer or public official means a person elected or appointed to perform executive, administrative, legislative, or quasi-judicial functions for the City of Barre. Persons elected or appointed must be legally able to hold the position.

Teams means a group of City Staff appointed to provide input or recommendations offered as a guide to topic-specific action to City Staff or designee. Solicitation and appointment are made by the City Manager or a designee of the City Manager.

Work Group means a group of two or three City Councilors that work collaboratively to provide a service or function of the City of Barre. Solicitation and assignment are made by the Council.

D. Procedures.

City Council.

- 1. The Mayor shall serve as the Chair of the council. In the absence of the Mayor, the council member present with most seniority shall serve as acting Mayor in the Mayor's absence.
- 2. The Mayor/Chair shall preserve order in the meeting and shall regulate its proceedings by applying these rules and making determinations about all questions of order or procedure and shall enforce these rules as required by 1 V.S.A. § 312(h).
- 3. Order and decorum shall be observed by all persons present at the meeting. Neither members of the council, nor the members of the public, shall delay or interrupt the proceedings or the peace of the council, or disturb any member while speaking. Neither members of the council, nor the members of the public, shall refuse to obey the orders of the Mayor or other presiding members. Any person making personal, impertinent, slanderous, threatening, or profane remarks shall be called to order by the Mayor and may be ordered removed from the meeting if necessary.
- 4. A majority of the seats on the council shall constitute a quorum. If a quorum of the members of the council is not present at the meeting, the only action that may be considered by the council is a motion to recess or adjourn the meeting.
- 5. No single member of the council shall have authority to represent or act on behalf of the council unless, by majority vote, the council has delegated such authority for a specific matter at a duly- noticed meeting and such delegation is recorded in the meeting minutes.

Regular Meeting of the Barre City Council Held March 29, 2022

The Regular Meeting of the Barre City Council was called to order in person and via video platform by Mayor Jake Hemmerick at 7:00 PM at Barre City Hall. In attendance were: From Ward I, Councilors Emel Cambel and Thom Lauzon; from Ward II, Councilors Michael Boutin and Teddy Waszazak; and from Ward III, Councilors Michael Deering and Samn Stockwell. City staff members present were Manager Steve Mackenzie, Finance Director Dawn Monahan, and Clerk/Treasurer Carol Dawes.

Absent: NONE

Adjustments to the Agenda: Moved acceptance of Reina Dean's resignation from the Police Advisory Committee to the consent agenda. Added appointment to Central Vermont Public Safety Authority board to the new items agenda. Rearranged new agenda items to accommodate those in attendance.

City Clerk & Treasurer Report –

Clerk/Treasurer Dawes reported on the following:

- Water/sewer bills were mailed earlier this month, and are due by March 31st.
- Brian Judd has filed paperwork to have the Vermont Supreme Court reconsider its recent decision in Judd v. City of Barre.

Liquor Control Board – It was noted the liquor license renewal applications were not included in the Council packet. Clerk Dawes said that step is required for annual renewals as per City policy and agreement with the Division of Liquor Control. The applications will come to the Council next week.

Council approved an educational sampling event permit from Matt Poquette for the VT Burlesque Festival at the Barre Opera House on April 22nd on motion of Councilor Lauzon, seconded by Councilor Waszazak. **Motion carried with Councilor Boutin abstaining.**

City Manager's Report –

Manager Mackenzie said the only addition to his written report is that the cast on his left arm will be removed tomorrow.

Unfinished Business – NONE

New Business -

B) Amendment to Municipal Bodies & Appointments Policy.

Mayor Hemmerick reviewed draft amendments to the policy. Council made additional adjustments around posting deadlines, language regarding youth appointees, numbers of board and committee members, and providing reasonable accommodations as needed. Council approved the policy as amended on motion of Councilor Stockwell, seconded by Councilor Deering. **Motion carried.**

Councilor Lauzon asked to have a discussion at a future meeting on use of executive sessions for appointments to committees and boards.

C) Police Advisory Committee Resignation & Appointment.

- i. Resignation of Reina Dean [moved to consent agenda]
- ii. Appointment of Sandy Rousse

Resident Sandy Rousse expressed her interest in and experience around the Police Advisory Committee. Council approved the appointment on motion of Councilor Lauzon, seconded by Councilor Boutin.

Motion carried.

D) Planning Commission Appointment (One Vacancy)

- i. Rosemary (Lynn) Averill
- ii. Joe Reil

Residents Rosemary Averill and Joe Reil expressed their interest in and experience around the Planning Commission. It was noted there is one vacancy on the Planning Commission at this time. Councilor Lauzon tendered his resignation from the Planning Commission so as to create another vacancy. Council accepted Councilor Lauzon's resignation, and approved appointing both Ms. Averill and Mr. Reil to the Planning Commission on motion of Councilor Lauzon, seconded by Councilor Waszazak. **Motion carried**.

E) Warned for 7:30 pm: Downstreet Housing's request for approval of VCDP Application for Granite City Apartments Project and adoption of Resolution 2022-02.

Mayor Hemmerick opened the hearing at 7:53 PM. The Mayor noted this grant program is administered through the Vermont Agency of Commerce and Community Development. He said he works for ACCD, but has no involvement with this grant program.

Nicola Anderson, Director of Real Estate Development for Downstreet Housing, said the \$500,000 grant will help fund the creation of nine apartments in the old Ward 5 school building, and make improvements to the Bromur Street apartments. There was discussion on federal requirements for surveillance; outreach in the Ward 5 school building neighborhood; concerns about lack of sidewalks, paving issues, blind curves and stormwater runoff in the area; Transportation Advisory Committee review of intersections in the area for increased traffic.

Mayor Hemmerick closed the hearing at 8:06 PM. Council approved the application and resolution 2022-02 on motion of Councilor Stockwell, seconded by Councilor Cambel. **Motion carried.**

A) Barre Area Development Corporation Appointments

- i. Appointment of Manager Mackenzie as Staff Representative
- ii. Nomination & Appointment of Council Liaison

Manager Mackenzie recommended the staff representative be the City Manager by title; not a particular named person. Council approved appointing the sitting City Manager as the staff representative to the BACD board on motion of Councilor Lauzon, seconded by Councilor Stockwell. **Motion carried.**

Councilor Deering volunteered to be Council liaison to the BADC board. Council approved the appointment on motion of Councilor Boutin, seconded by Councilor Waszazak. **Motion carried.**

Added) Appointment of City representative to Central Vermont Public Safety Authority Board.

Montpelier resident Steve Whitaker noted one of Barre City's representatives tendered his resignation.

Montpelier resident Steve Whitaker noted one of Barre City's representatives tendered his resignation back in December, and the CVPSA charter calls for such vacancies to filled within 45 days. There was discussion on state initiatives to upgrade dispatch systems and improve cellular coverage statewide, and it was noted funding may flow through public safety authorities.

Councilor Cambel volunteered to be appointed to the CVPSA board as one of Barre City's representatives. Council approved the appointment on motion of Councilor Lauzon, seconded by Councilor Boutin. **Motion carried.**

F) American Rescue Plan Act Funding Community Outreach.

Mayor Hemmerick reviewed his memo on a proposed process to collect public feedback, which includes engaging a consultant. There was discussion on using data from the All In For Barre community visit, using the upcoming strategic planning process to help inform the work, reviewing infrastructure needs before soliciting community ideas, reviewing the division of funds informally agreed upon by the previous Council, and using online surveys to gather community input.

Council approved the proposal as outlined by the Mayor on motion of Councilor Lauzon, seconded by Councilor Stockwell. **Motion carried with Councilor Boutin voting against.**

G) Update on the Status of Bond Projects & Upcoming Capital Equipment Items.

Manager Mackenzie reviewed his spreadsheets and noted 56% of the bond projects have been completed, and 69% of the funding has been expended. The largest outstanding project is the replacement of the North Main Street pump station. There was discussion on the funds allocated for review of the Merchant's Row project, and the Quarry Street intersection project.

H) Update on Planning Permitting Assessing Department Staffing.

It was noted there are concerns about the ongoing vacancies for the assessor and permit administrator. Manager Mackenzie said the wages for the positions have been increased, and they've been re-advertised. Payroll Clerk Heather Grandfield, who was the previous permit administrator, will be working approximately 2 days/week to help with processing permits. There was discussion on the pros and cons of hiring a headhunter, and asking Barre Area Development Corporation to help spread the word.

Councilor Stockwell noted the ongoing Front Porch Forum discussions on roaming cats and dogs, and asked if the City's Animal Control Officer will capture feral cats. Manager Mackenzie said yes.

Councilor Boutin said Wobby Jewelers owner Mary Jane Magnan was recently featured on the Barre Business Hour. Ms. Magnan said she frequently hears people say there's nothing happening in Barre, but last summer she vowed to attend all activities to see firsthand all the great things happening in the area. Councilor Boutin said he is looking forward to a tour of the new Rainbow Bridge Community Center.

Mayor Hemmerick reported on the following:

- Sunday's welcome event for Police Chief Braedon Vail was wonderful.
- There will be a seed swap this weekend at the Aldrich Library.
- Interviewed by Spaulding High School civics students.
- Housing Working Group met.

The meeting adjourned at 9:10 PM on motion of Councilor Waszazak, seconded by Councilor Stockwell. **Motion carried.**

- (b) If the municipality so votes at a meeting duly warned for that purpose, the local control commissioners may, in the exercise of their authority under this title, condition the issuance of licenses and permits upon compliance, during the term of the license or permit, with any ordinance regulating entertainment or public nuisances that has been duly adopted by the municipality at a meeting duly warned for that purpose.

(c) The local control commissioners may, in the exercise of their authority under section 210 of this title, suspend or revoke a license or permit for a violation of any condition placed upon the issuance of the license or permit under subsection (b) of this section.

BACKGROUND/SUPPLEMENTAL INFORMATION:

Liquor license applications and renewal applications require the signature of all Councilors voting upon the applications. The City of Barre petitions the Division of Liquor Control for authority to "blanket" approve the applications by presenting them in a group to the Council and having the Council approve them as a batch. The authorization given by DLC establishes the required procedures for presentation to and approval by Council:

- 1.) The Council is given a list of all applicants along with copies of applications;
- 2.) The Council is asked if they have any concerns with any applicant on the list, and, if so, those are discussed and voted on separately;
- 3.) All other applications are recommended for approval in one motion; and
- 4.) The City Clerk affixes a label to each application noting approval by the Council acting as the local Board of Liquor Control Commissioners, and the date of the warned meeting at which approval was granted.

BACKGROUND/SUPPLEMENTAL INFORMATION:

The attached contract is to prepare a <u>Complete</u> Reappraisal, which is the most comprehensive reappraisal which can be undertaken; it will simultaneously re-assess all properties on a consistent basis to eliminate any inequities that may have developed over the 20 years since the last reappraisal.

A **complete reappraisal** is a reassessment of all City properties including the following:

- interior property inspections
- development of new land and building pricing schedules
- adjustments and factors.

The **goal** is to implement new values for all properties that **reflect 100% of fair market value** across the community.

Due in part to the length of time it took to negotiate a Final Contract, and NEMC's expansion of its workload, the completion of this re-appraisal has been extended from 2024 to 2025.

Hi Jake, Hi Steve,

I met with the Trash committee last Friday, and the committee agreed to discontinue meeting. The larger scope of the work, as suggested by former Mayor Herring, was to evaluate the possibility of the city contracting with one hauler and offering that to residents to reduce truck traffic. While that has it merits, a similar move was recently defeated in Burlington. The haulers were united in protesting against this idea. Trying a similar proposal in Barre would bring the same response and researching the possibility would require extensive work and a larger committee than 3. It does not seem to me to be a pressing concern at this time.

We accomplished some tasks, thanks to the work of the committee members, and we have some recommendations going forward that we would like to bring to Council in April.

- 1. Add a scaled-back green-up day in the late fall, mid to late October. The city provides the bags and the bags can be dropped off at DPW, but there is no roadside pick-up.
- 2. Add information about composting to the city's website.
- 3. Roll ongoing development of resources for composting into the gardening committee.

4.

Whether the committee should be put on hiatus, disbanded permanently, or rolled into another existing committee is a question for the Council. I think consolidating committees when possible would reduce the workload for the staff, increase communication about overlapping interests, and potentially bring more volunteers to less popular committees by combining them into larger groups.

In order to keep you informed of the Department activities of the office, I'm forwarding this report of activities of the City staff for the previous Friday - Thursday. If there are any additional questions please do not hesitate to ask.

1. CLERK/TREASURER'S OFFICE:

- The House Government Operations Committee has merged together the City's 2021 charter changes and this year's charter changes into bill H.444, which has passed out of the committee and is in front of the House for action today. Once it has passed the House, it will go back to the Senate for concurrence of the amendments. The bill would go into effect upon passage. Thanks to the Barre City Representatives for pushing these changes forward.
- We have received \$15,000+ to date from the VT Homeowners Assistance Program (VHAP), which provides assistance with property taxes, mortgages, utilities, and condo or homeowner association fees. It is being administered by the VT Housing Finance Agency and Downstreet is providing assistance to those interested in registering for the program. The program continues to be poorly administered.
- Also participating in the Low Income Household Waste/Water Assistance Program
 (LIHWAP) being administered through DCF Economic Services. This program is
 offering funding support for delinquent water/sewer bills. Unlike the VHAP program,
 administration of this program is going very smoothly, with good communications and
 data-sharing.
- 2022 dog licenses are on sale. All dogs are required to be licensed by April 1st. We are running behind pre-COVID licensing numbers, and will be sending out reminder postcards to those who licensed dogs over the past 2 years, but not this year to date.
- Water/sewer bills were mailed at the beginning of the month. They were due yesterday. We received 230 payments through the credit card portal on the website.
- Liquor license renewals have been mailed to all license holders. Expect to bring the first batch of licenses to Council for approval at the April 5th meeting. All liquor licenses expire the end of April.

2. BUILDING AND COMMUNITY SERVICES:

- The "welcome" event for Chief Vail was held on Sunday in Alumni Hall. There were approximately 50 75 attendees during the two-hour event.
- On Monday, Sue Higby and I took Professor Michael Kelly and four engineering students from Norwich University through the Auditorium. This group of students will be working on developing engineering drawings relating to expanding/enhancing the locker rooms, rest rooms and referee rooms in the AUD.
- On Tuesday afternoon, Chief Vail held a department meeting in Alumni Hall.
- The BOR spring sports practicing season began on Tuesday evening with BYSA lacrosse holding practices. They also held practices and registrations on Thursday evening.
- On Wednesday, I participated in interviewing a candidate for an opening in the police department. I have volunteered to sit in on the interviewing panel along with Finance Director Dawn Monahan.
- The DMV conducted CDL testing on Wednesday in the Civic Center parking lot.
- Thursday morning I met with Cody Morrison at the AUD for a walk through. We are looking into applying for funding to replace the heating system, add air conditioning as well as making electrical improvements to bring the system up to code.
- On Thursday afternoon, I participated in a Zoom meeting with the Manager, DPW
 Director and Cody Morrison regarding the federal funding packages that may be
 available through our Congressional team.
- The Red Cross held a blood drive on Friday in Alumni Hall.
- I worked with several groups booking time in the BOR for batting cages and lacrosse practices. I also worked with the coordinator for this weekend's CYO New England Regional basketball tournament scheduled for the AUD. I also spent time with several families and local funeral homes setting up spring burials.
- Donny started spring clean up operations at Hope Cemetery including the removal of the brush piles on the exit road. We had one full burial on Thursday.
- The facilities crew has the AUD ready for the weekend basketball tournament and spent time getting the tennis courts ready for use.

2a. RECREATION:

- Worked on a presentation for the Vermont Recreation and Parks Association.
- Updated software on batting cage requests (B.O.R.) Created accounts for new groups using the facility.
- Worked with volunteers (2 half days) to stuff more of the eggs and prepare for the Egg Hunt.
- Continued to work on efforts to attract Lifeguards for the summer. I have a new flyer in the works. Looked into Lifeguard Training recertification.
- Continued working on a summer program booklet -waiting for grant announcements. A grant award would drastically reduce the cost of the program. Any prior registrations would create the need for refunds, etc.
- Enrolled the Pool Director and myself in a June Aquatics Risk Management online course.

- Connected with pool employees from last year to see who is returning.
- Connected with a Committee Chair for agenda items on an upcoming meeting.
- Was out of the office one day this week.
