Regular Meeting of the Barre City Council Held March 31, 2015

The Regular Meeting of the Barre City Council was called to order by Mayor Thomas Lauzon at 7:00 PM at Barre City Hall. Council approved a Request to Cater Permit application from Jerry's Sports Tavern for the autism fundraiser on April 11th at the auditorium from 6:00 – 10:00 PM on motion of Councilor Smith, seconded by

Councilor Dindo. Motion carried with Councilors Boutin and Chadderton abstaining.

City Manager's Report – Manager Mackenzie reported on the following:

- Meeting next week with abutters to the Enterprise Aly project to discuss scheduling for this summer's construction work.
- Gunner's Brook flood mitigation public presentation is April 16th.
- The Budget Committee's survey is available through April 3rd.
- The City has contracted with VLCT to conduct the search to fill the City Planner position.
- The Manager has begun reviewing resumes to fill the DPW director position.

Mayor Lauzon said he spoke with VTRANS after experiencing problems with the traffic signal at the North Main Street/Route 62 intersection over the weekend. The state plans on replacing 11 optical sensing devices with radar, however, it will take 2-3 months to complete the process. There was discussion about pedestrian safety and the intersections of Route 62/Berlin Street and Berlin/North Main Streets.

Added) Thunder Road Annual Car Show & Parade.

Mayor Lauzon reviewed the memo from Thunder Road requesting that a portion of North Main Street be closed the morning of May 2nd to host the annual car show, followed by the traditional parade of cars from North Main Street to Thunder Road. There was discussion about costs incurred by the City and clean-up following the event.

Council approved the street closure and parade permit request on motion of Councilor Poirier, seconded by Councilor Dindo. **Motion carried.**

Clerk Dawes said she will mail Thunder Road an Entertainment License application, as she has done in the past.

A) Approval of Changes to Emergency Operations Plan.

Council approved the Emergency Operations Plan on motion of Councilor Herring, seconded by Councilor Smith. **Motion carried.**

B) Enterprise Aly Project Costs, Funding and Schedule.

Manager Mackenzie reviewed the funding for the project and noted that the gap has been closed. The Manager reviewed the changes in the project and funding which helped close the gap. He said the local share is approximately \$346,000 and helps cover work that will be done on private property, which cannot be done with state or federal funds. Portions of the local share will include funds from the Semprebon Annuity and the Semprebon Bike Path funds.

Councilors voiced their support for the project and the funding plans. Mayor Lauzon said the project will be on next week's agenda for Council approval.

The Manager reviewed the construction schedule, operation and monitoring schedule, concept plan, private easements plan, excavation plan and soil vapor extraction system plan.
