- The Police Department is looking for one more bike patrol Bee for the summer.

Councilor Smith asked that leasing of the Wheelock building be placed on next week agenda for discussion.

Councilor Dindo said he has received many compliments on how good the cemeteries look.

New Business -

A) Barre Partnership Update.

Barre Partnership executive director gave an update on Partnership activities:

- Recently kicked off the spring membership campaign.
- Applied for a National Life grant to assist operations and programs.
- Held a networking event last week. Hoping to hold at least 4 such events/year.
- Working with BADC on an antiques collaborative grant application through USDA.
- Promotion Committee working with downtown merchants to offer later hours on Fridays through the summer.
- Currier Park summer concert series starts June 10th and runs for 10 weeks. They will be assessing data on the downtown impact of the concerts.
- Design Committee working on summer banner designs, which should be up before the end of June. Then work will begin on designing the new winter banners.
- The updated downtown brochure and map will be coming out shortly.
- New fall event ó 5K race over Veterangs Day weekend. Hoping for 300-400 participants.
- Looking to develop an event for the 1st quarter of the year.
- Gave a Heritage Festival update.

B) Authorization to Accept Enterprise Alv Amended DTF Grant.

Manager Mackenzie said Council needs to accept the amended DTF grant for \$100,000 for Enterprise

Aly. Council approved the acceptance and authorized the Manager to sign on behalf of the City on motion of Councilor Smith, seconded by Councilor Herring. **Motion carried.**

Mayor Lauzon gave a brief review of the update and said the projected fund balance is \$200,000. Manager Mackenzie said he will give the next report in mid-July, and will prepare a list of options for the fund balance. Mayor Lauzon said he expects that conversation to be had in the context of FY17 budget preparations.
