B) Jack Feccia from Scout Troop 795.

Boy Scout Jack Feccia gave a PowerPoint presentation on his Eagle Scout project, which was removing the overgrowth from the landscaping along the Rite Aid/Lenny's parking lot on North Main Street. He said 28 people worked a total of 153 hours to clear 600 feet of area. They made 16 trips to the stump dump with truckloads of debris. He thanked his fellow Scouts, friends and family for helping, and said the project helped him develop leadership and communications skills. All those in attendance thanked Mr. Feccia with a round of applause, and Mayor Lauzon said the City will be sure to maintain his good work going forward.

C) Recognition of Lorraine Brislin from Community National Bank for Support of Barre City Emergency Medical Services.

Deputy Fire Chief Joe Aldsworth said Lorraine Brislin has been a significant supporter of the City's

emergency medical services, and has helped raise money to purchase life-saving equipment. Clerk Dawes read resolution #2015-13 honoring Ms. Brislin for her service to the City and community. Council approved the resolution on motion of Councilor Smith, seconded by Councilor Boutin. **Motion carried.**

A) Warning of First and Second Public Hearings for Charter Changes.

Clerk Dawes reviewed the timelines for charter change public hearings, and said she recommends warning the first public hearing for Thursday, January 28th and the second public hearing for Tuesday, February 2nd There was general discussion about the proposed charter changes related to the number of BCEMS school board members and the creation of a deputy mayor position for the City. Council approved the warnings as recommended on motion of Councilor Herring, seconded by Councilor Boutin. **Motion carried.**

D) Approval of Enterprise Aly Grant Anticipation Note Extension Documents.

Clerk Dawes said the three month extension will give the City time to finalize reimbursement requests for the Enterprise Aly project expenses. Council approved the allonge on motion of Councilor Boutin, seconded by Councilor Smith. **Motion carried.**

E) Ratification of the USW Contract.

Manager Mackenzie reviewed some of the highlights from the contract including health coverage, workers' compensation language, consistency in longevity and compensation levels. Council ratified the contract on motion of Councilor Herring, seconded by Councilor Smith. **Motion carried.**

Manager Mackenzie said negotiations continue on the firefighters' contract. The Manager said they expect to be reaching out to a mediator for some assistance in the negotiations.

F) Authorization to Execute FY17 Blended Heating Oil Contract.

Mayor Lauzon said the City has been extended an opportunity to blend the FY16 and FY17 heating oil prices. Manager Mackenzie reviewed oil usage over the past couple of years, and said the City is working with both the former oil supplier Irving Oil and current supplier Dead River to coordinate deliveries.

Council authorized the Manager to execute the contract, subject to ratification by the Council, on motion of Councilor Herring, seconded by Councilor Smith. **Motion carried.**

Mayor Lauzon reviewed other items Council will be working on in the new year, including the FY17 budget, police staffing levels, street department staffing levels, funding for deferred maintenance at the auditorium, parking, and assessment of the public works garage.
