New Business -

A) Discussion/Action Re: Ceding City Dispatch Operations & Authority to CVPSA

Mr. Aumand reviewed his handout and said it included a revised plan for ceding dispatch authority to CVPSA. The changes take into consideration discussions with both Councils and individual mayors, councilors and staff over the past few weeks. It was noted that both Councils were seeing the revisions for the first time this evening. Mr. Aumand said the plan is to implement the transition on July 1, 2017, and the first year's budget would be based on what both cities are currently spending and budgeting for dispatch services.

There was discussion on:

- budgeting for dispatch services and CVPSA operations
- withdrawal provisions
- developing a 5 year budget plan
- governance by an executive committee consisting of Mr. Aumand and the chiefs
- assumption of pension liabilities
- current and future technology investments
- revenue opportunities through contracts for providing dispatch services to other communities
- Developing a 3-5 year projection and information on market share
- Recouping investment
- Developing fail-safes, policies, rules and procedures, and run tabletop exercises before completing the transition
- Determining the long-term financial impact on each municipality
- CVPSA board members visiting the call centers
- Providing separate police and fire dispatch
- Uncertainty creating employee stress

Others who spoke were Barre City Public Safety Chief Tim Bombardier, Montpelier Police Chief Tony Facos, Montpelier Finance Director Todd Provencher, Montpelier City Manager Bill Fraser; Barre City Manager Steve Mackenzie, Steve Whittaker, Charles Loughlin, Laura Hedin, Danielle Frattini, Jim Ward, and Carrie McCool.

Mr. Aumand will meet with the chiefs in each municipality and the board will present again to each Council in the near future.
