


#### PUBLIC ASSISTANCE DAMAGE ASSESMENT

- City issued an RFP for rehabilitation of City Hall, Public Safety Building, and Wheelock Building
  - O RFPs due Thursday, September 7
- Scoping meeting with FEMA began our 60-day clock for Public Assistance project identification
  - o 56 projects identified
    - 4 emergency protective measures, 8 culverts, 8 road repairs, 6 landslides and many others
- Paving contract for flood repair awarded by Council last week
  - O Cliff Street paving currently ongoing, Pleasant Street up next



### STREET CLOSURES



- Berlin Street between N. Main Street and Smith Street CLOSED pending pavement repairs at the bridge
- Pike Street between George Street and Howard Street CLOSED due to landslide concerns
- W Patterson Street between Ayers Street and Orange Street CLOSED to vehicle traffic, OPEN to limited and necessary pedestrian traffic
- Merchant Street Between Warren Street and Maple Avenue/VT-14 CLOSED 24 hours a day until September 15 for State-funded infrastructure improvement project
- Cliff Street and Pleasant Street will have intermittent closures for paving and repairs this week
- Maple Avenue/VT-14 near Hope Cemetery will have intermittent one-way traffic due to the State-funded infrastructure project

#### PRIVATE DEBRIS COLLECTION HAS ENDED

- State contractors and City volunteers picked up the last 16 remaining debris piles by Saturday, August 26.
- Residential debris collection by the City and the State contractor has ended.
  - O Residents are responsible for debris removal. Rainbow Bridge Community Center has offered assistance to any residents in need of help with continuing debris removal.

NO yard waste

NO household hazardous waste

#### LANDSLIDES

- Council acted on a contract to formally retain a geo-technical firm for assistance in understanding and remediating landslides.
  - Pike Street (~4 weeks)
    - Desktop analysis subsurface exploration, slope stability modeling, report
  - O Brooklyn Street, 54 West Patterson, West Patterson between Ayers and Orange Streets,
    bike path, Railroad Street/VT-62, Foster Street, Kinney Place/Public Works Garage
    (~2 weeks)
    - Probably cause, potential continued movement, preliminary repair options



#### ASSESSMENTS OF RESIDENTIAL DAMAGE

- ~363 structures containing 517 units sustained some level of damage
- $\sim$ 17 homes Substantially Damaged,  $\sim$ 14 additional homes anticipated to also be determined to be Substantially Damaged
- As of this afternoon, 112 homes green tagged, 77 yellow tagged, 10 red tagged (landslides, structural issues).
- Priorities for the City:
  - O Finalizing assessment and notifications to homeowners about Substantial Damage determinations
  - Narrowing number of impacted individuals
  - O Projecting and prioritizing homes that can be rehabilitated quickly before winter
- City has provided FEMA with data and maps about potential parcels for the placement of trailers
  - O Standard: 3 acres, not in the floodplain, connected to water and sewer at the right-of-way
  - o 18 properties identified (only 2 City properties: Auditorium and bike patch section near dog-park)
- State has made some resources available for staffing to assist with homeless individuals and re-housing.
  - O Next step: Budget and deliverables for the position



#### **VOLUNTEER ACTIVITIES**

- Saturday statewide Clean Up Day was a great success
  - 90+ volunteers showed up
  - O Governor's team added soil and re-seeded Dente Park and Nativi Playground
  - O Crews collected tires and the last remaining debris piles
  - 0 16 loads of mud were removed
- City volunteer hub is no longer active on weekdays. Stay tuned for weekend volunteer hub information and opportunities to help.

#### FLOOD IMPACT ON CITY BUDGET


- Staff will be preparing an analysis of expected budget impacts to present to Council in September.
- Concerns with loss of revenue and long-term cash flow if FEMA funding is not received in a reasonable time period.
- Expect difficult mid-year adjustments and a challenging FY25 budget development process
  - See-Click-Fix contract has been terminated, ~\$5,500 savings



#### ODDS AND ENDS

- FEMA Disaster Recovery Center remains staged in the Auditorium basement
  - Seven days a week, 8AM to 7PM
- Parking meter enforcement will resume on Tuesday, September 5.
- Rehabilitation of the old Police Department continues when completed, the space will become a one-stop resource center for flood recovery. Anticipated launch is by mid-September.
