REQUEST FOR QUOTATION RESIDENTIAL APPRAISAL SERVICES GUNNERS BROOK PHASE 2 FLOOD MITIGATION HMGP BUY-OUT PROGRAM April 6, 2017

The City of Barre, Vermont is procuring the services of a State of Vermont Certified Residential Real Estate qualified to provide appraisal services in support of the Gunners Brook Phase 2 Flood Mitigation Project in the area of Brook Street in Barre. Two (2) properties are required to be separately appraised as part of this project. A map showing the locations of the subject properties is attached. Services to be provided include preparation of an estimate of the Fair Market Value of each parcel, prepared in accordance with the Uniform Standards for Professional Appraisal Practice (USPAP). Each appraisal is to reflect the Fair Market Value of the subject properties immediately prior to the date of the flood, which occurred on July 26, 2015.

The subject properties located in Barre City are as follows:

- 1. 85 Brook Street (Patrick C. Gilbert);
- 2. 87 Brook Street (Leslie A. Lucas)

The selected appraiser will be notified on or around Wednesday, April 19th. For informational purposes, **the City's goal for completion of these appraisals is on or before May 12, 2017.** As noted above, this is the City's' desired/target schedule. However, **it is not a disqualifying schedule.** The City will receive and consider bids from vendors unable to commit to the above schedule in the event no vendor is able to meet the above target schedule.

You will be required to submit a digital copy of your appraisal(s) along with two (2) paper copies of a complete report using the Uniform Residential Appraiser Report Form 1004, including:

- Photographs;
- Comparables;
- Location Map;
- Building sketch;
- Notation indicating presence of observed water well, septic tank, and above or below ground fuel tanks, and

• Other appropriate addenda.

If you are interested in being considered for this work, please submit a written proposal **no later** than 11:00 a.m., Friday, April 14, 2017. You proposal should include the following:

- 1. Cost quotation for **each** property parcel;
- 2. Completion Schedule;
- 3. Proof of Certification; and
- 4. Please indicate any assumptions or conditions associated with your proposal.

Selection will be made in accordance with the City of Barre Procurement Policy. In addition, while fee is an important selection consideration, it is not necessarily the exclusive basis for selection. The City of Barre reserves the right to select the firm submitting the proposal deemed to be most responsive to this RFQ and/or in the best interests of the City of Barre.
