## **INFORMATION FOR PAVING CONTRACTORS**

### **Miscellaneous Paving Assignments Re-Bid**

The City of Barre is accepting bids from qualified Paving Contractors for applying bituminous concrete pavement to various and miscellaneous paving projects throughout the City of Barre for FY 18/19, July 1, 2018 - June 30, 2019. Bids will be **received until 11:00 AM on July 20, 2018**, at which time they will be opened. Bids must be submitted to:

Paving projects will consist of but not limited to the following:

- 1) Various utility ditches created by the City during its normal utility maintenance activities.
- 2) Portions of driveways and walkways disturbed during the City's road reconstruction projects.
- 3) Various ditch lines.
- 4) Corrective work (depressions, etc.)
- 5) Install bituminous concrete curbing as directed by the City of Barre.
- 6) Install bituminous concrete sidewalks as directed by the City of Barre.

The City of Barre reserves the right to utilize the lowest qualified bidder whenever and where ever possible however, if the Paving Contractor cannot accomplish the work in a timely fashion – to the satisfaction of the City of Barre, the next lowest available bidder will be utilized. As other paving jobs develop, the City will again contact the lowest bidder and repeat the process as needed. The City reserves the right to utilize one or more Paving Contractors simultaneously if necessary. The City of Barre reserves the right to accept the bid(s) deemed to be in the best interest of the City of Barre.

The paving will involve that which is applied by hand (HANDWORK), that which is applied by a paving machine (BOX APPLIED) and that, which is applied, by CURB-

MACHINE. A contractor need not propose for all three types of miscellaneous paving for the bid to receive consideration.

## **GENERAL CONDITIONS**

### REFERENCE: Experience

The City of Barre reserves the right to require work references and make investigations, as it deems necessary, to determine the ability of the Paving Contractor(s) to perform the work.

### INSURANCE: General Liability

The Paving Contractor shall purchase from and maintain in a company or companies lawfully authorized to do business in the State of Vermont, such insurance as will protect the Paving Contractor from claims which may arise out of or result from which the Paving Contractor or by anyone directly or indirectly employed by any of them, or by anyone whose acts any of them may be liable.

THE PAVING CONTRACTOR SHALL PROVIDE A CERTIFICATE OF INSURANCE. The City of Barre shall be listed as the Certificate holder. The policy shall cover both "bodily injury" (personal injury) and "property damage". The minimum limit of liability shall be one million dollars (\$1,000,000.00).

### INDEMNIFICATION

The PAVING CONTRACTOR(S) will indemnify and hold harmless the City of Barre, their agents and employees, from and against all claims, damages, losses and expenses including attorney's fees, arising out of or resulting from the performance of the WORK; and is caused in whole or in part by any negligent or willful act or omission of the PAVING CONTRACTOR(S), anyone directly or indirectly employed by any of them or anyone from whose acts any of them may be liable.

In any and all claims against the City of Barre or any of their agents or employees, by any employee of the PAVING CONTRACTOR(S), anyone directly or indirectly employed by any of them, or anyone for whose acts any of them may be liable, the indemnification obligation shall not be limited in any way by any limitation on the amount or type of damages, compensation or benefits payable by or for the PAVING CONTRACTOR(S) under workman's compensation acts, disability benefit acts or other employee benefits acts.

### WORKERS COMPENSATION

The Paving Contractor(s) hired by the City of Barre shall provide full workers' compensation benefits. THE PAVING CONTRACTOR(S) SHALL PROVIDE A CERTIFICATE OF INSURANCE TO CONFIRM A VALID WORKER'S COMPENSATION POLICY IS IN FORCE.
