Sealed Bids for the construction of the North End Pump Station Replacement will be received by Barre City, at the office of the City Manager, until 2:00 PM local time on April 26, 2022, at which time the Bids received will be publicly opened and read in the City Council Chambers, 6 North Main Street, Barre, VT 05641. The Project consists of replacement of the North End Wastewater Pump Station and appurtenances as described herein and shown on the drawings.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis as indicated in the Bid Form.

The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Upon request, Bidding Documents in PDF format will be provided to prospective Bidders who have purchased printed Bid Document. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.
