The revised bill REFLECTS the additional amounts you owe for the first and second quarters. Please be sure to add those amounts to your February 15<sup>th</sup> installment. All amounts due by February 15<sup>th</sup> that remain unpaid after that date will be turned over to the delinquent collections office, and will be subject to the appropriate late penalties and interest charges.

**DELINQUENT BILLS:**

If your September 16<sup>th</sup> and/or November 15<sup>th</sup> property taxes became delinquent, any payments made to the delinquent collections office after those deadline dates ARE NOT REFLECTED on the revised bill.
