The Barre City Police Department arrived on scene along with an Officer of the Berlin Police Department. Upon further investigation, it appeared that the operator of the vehicle, Robert Rouser, was operating with a criminally suspended license and was placed under arrest for Criminal DLS and Suspicion of Driving While Intoxicated. The male was later determined to have been operating a motor vehicle approximately 3 times over the legal limit of .08%.

Further investigation revealed that the female passenger, Ceara Concannon, was in violation of her Conditions of Pre-Trial Release and was placed under arrest. The female had also attempted to resist arrest.

Austin Scott, the 2nd passenger, was exiting the Dollar General after placing the two individuals into police custody. While attempting to speak with Scott about any Probation and Parole questions, Scott attempted to flee the scene and was later taken into police custody. Scott was also currently in violation of Conditions of Pre-Trial Release.

All three individuals were lodged at the Barre City Police Department for Protective Custody and were issued citations to appear before the Washington County Superior Court.
