- Recent issues discussed: A Signage Plan will be developed and side trails posted by a
 representative of the SnoBee's. Posting will not be the Committee's responsibility. History of
 stream crossing restoration work (2012) and importance of not placing materials in stream and
 prior discussions with DEC Water Quality staff regarding impracticality and cost of building a
 bridge was discussed. Materials in the stream will be removed. Committee was not opposed to
 the paper street between Quinlan Drive and Cow Pasture being used as an access as long as riders
 are respectful of the Cow Pasture property and remain on the connector trail once in the Pasture.
 Tim Bashaw, will research ownership of the parcels of land and obtain permission from
 landowner(s) if the trail passes on private property.
- Groomer can barely pass through the gate. VYCC will be asked to widen gate opening. Damage to the gate hinges is needed.

Committee Member Activities:

- Chris -Annual council update will be scheduled in May. Semperbon Fund balance is as of 3-14-18 is \$12,558.43. Committee is supportive of Chris investigating acquiring Ford property, which is listed in the Management Plan as a high conservation priority (Table 10). The parcel would be a bridge to residential areas now accessing the Cow Pasture through the Perrin property if access is restricted in the future.

 of mouth. Alex and Maura will revise the *Trail and Infrastructure Projects* Management Plan Table
 and identify completed projects. Remaining project are potential 2018 VYCC projects. The revised
 Table will be included in City Council update.
