Topics Discussed:

Reviewed previous minutes.

Multi Year Agreement price confirmed at \$1,475 for this year Art makes motion to accept, Brent seconds

Reviewed Jeff's proposed Civic Center Rate Sheet for FY20-21

Proposal has BOR keeping the same rate, all others 5% increase

Area ice rinks – Montpellier, Waterbury, Stowe all \$5 - \$10 less than BOR

Discuss dropping BOR rates, non-peak hour rates, and effect on BOR usage

Art motions to leave Aud rate at \$1,550 for existing customers with a \$2,000 rate for new renters, and decreasing BOR rates from \$215/hr to \$205/hr

Charlie amends with a \$1,750 rate for new customers. Jon seconds. Amendment passes.

Art motion on Aud pricing, with amendment, and BOR reduced rates passes

New Aud customers - \$1,750 per day, existing customers within 2 years - \$1,550 per day, long term contract - \$1,475 per day. BOR hourly rate - \$205/hr

Sue inquired on softest days for renting Aud and possibly using a reduced rate.

Jeff states Aud has limited 9-5 weekday use from November to Mid-March

John states BYSA Basketball uses it on weekdays from 5-8 from Mid-November to Mid-February. BYSA has had difficulty getting this time. Important to serve community.

Jeff states April to October is soft on weekdays. Thursday night might be good to try.

Art motions \$1,000/day Aud Rental for Monday thru Thursday, June 1st to September 30 Charlie seconds. Motion passes.
