# Topic(s) Discussed

- 1. Call to order at 6:15PM.
- 2. Adjustments to the Agenda.

  - b. Zoom protocol discussion led by Joelen
    - i. Suggestions:
      - 1. Put members on mute put up hand up or show reaction if wanting to talk
      - 2. Chair in charge of letting folks talk, warning for disruptive (abusive, hurtful) behavior, second violation chair decides to remove from meeting,
      - 3. Question about those who dial-in, how can they participate, since they need to unmute themselves and can't raise a hand?
      - 4. Discussion about meeting in person
        - a. Steve It's the committee's decision to meet in person, which can be accommodated by the city.
      - 5. Committee members would like to be able to make both options available to allow more people to participate
        - a. Committee members or members of the public may have circumstances that prevent them from meeting in person
- 3. Approval of Minutes from Previous Meeting
  - a. Change in minutes recorded.

#### 4. Old Business:

- a. Continue discussion of priorities and reactions
  - i. Joelen recommended to make a list of the actions and then prioritize them and lump similar initiatives to gain efficiency
    - 1. Joelen Form working group around different topics to divide and conquer
    - 2. Ellen Options we can use are shared doc on Google that allows everyone to edit together
    - 3. Marichel Whiteboard function on Zoom can be used to work on lists as a group
    - 4. Joelen will review the list of priorities and send out lumped together priorities
- b. Responses to reading assignments (VLCT document, Burlington Equity & Diversity Strategic Plan, and Planning for Equity from the APA)
  - i. Marichel Demographic information is important for the assessment to understand what representation looks like in the community
  - ii. Joelen Demographic information is 10 years old and Barre has changed in that time, what other sources do we have access to
  - iii. Ellen Went to CityData.com and collated information on Barre,
    - 1. Burlington report was part of a contract with the VT Partnership for Fairness and Diversity can be adapted to fit Barre City's needs
    - 2. Start with definitions on equity and diversity (and additional terms)
      - a. Ellen is willing to work on base proposal for definitions and bring in community who is not represented to review these definitions
  - iv. Question of how can we increase our representation
    - 1. Joelen recommends having youth representatives and is willing to put the word out to and Jennifer agrees and is willing to help as well to involve youth
      - a. Steve No limit on size of committee and noted that the committee could approach the council to ask to expand the committee
      - b. Need to follow up and formulate plan before reaching out to the youth or others who are not represented on how they can participate with the committee
    - 2. Marichel Has a knack for connecting with people and encouraging follow-up
    - 3. Danielle has an interest in environmental justice access to water, access to nature, noise pollution, light pollution, etc.
      - a. Wants to be sure to include this our assessment

- a. Create member contact list with telephone numbers, addresses, email and the ways we both choose to communicate and what our choice of pronoun is.
- b. City Council requests
  - i. Joelen shared Major Herring priorities from August 27, 2020 email:

- 1. One is with conducting a survey of the demographics within the Boards, Committees and Commissions of the City to see if the different groups are being represented by diverse populations and to see if there are any areas that the City can improve in this area. We should be able to provide comparison data on Barre City as a whole for consideration.
- 2. The other item would be to review City Policies to see if there is any language or changes that you would suggest. The Civilian Oversight and Advisory Board may be looking into Policing policies first, so the Diversity and Equity Committee could start by reviewing any/all of the current council policies listed on the website at: <a href="https://www.barrecity.org/city-council-policies.html">https://www.barrecity.org/city-council-policies.html</a>
- ii. Ellen Black Lives Matter flag resolution proposed by councilor Jake Hemmerick need to follow up on this as we were listed to review the Flag Policy and the resolution.
  - 1. William First do no harm Black Lives Matter is divisive, giving an endorsement to a mov't with negative connotations
  - 2. **Ellen called Point of Order** and would like a planned discussion on flag question
  - 3. Marichel will invite Councilor Reil to the next meeting
  - 4. Jennifer made a recommendation to review the conversation and resolution
