- 4. Visitors and Communications: Amber Terway introduced herself and is in attendance to hear conversation pertaining to proposed Washington Street changes.

- 6. New Business
 - a. Transportation within Barre a discussion with Bill Ahearn on topics of interest to both committees
 - i. In-depth discussions pertaining to more cross-over meetings between the two committees and projects that impact both
 - ii. Terway offered to help put together an inventory of assets as they are so the two committees have a visual reference when discussing projects

- 1. Barre City maintains 40 scale maps of assets but they have not been reconciled to one another
- 2. The level of effort in maintaining in accurate records has varied so we have some issues with how up to date the paper records may be
- 3. Regional Planning Commission has digitalized GIS maps but they have not been reviewed by the City
- b. Discussion of Complete Streets in Barre: Washington St between Church/Perry
 - i. Hellein discussed the proposal the TAC discussed in November
 - ii. Suggestions include:
 - 1. Narrow the crossing distance of crosswalks with bulb outs
 - 2. Encourage street parking by protecting spaces from traffic with landscaping
 - 3. Reduce vehicle speed by narrowing travel lanes and establishing an urban visual rhythm
 - 4. Calm traffic entering Washington Street from Church Street at City Hall Park
 - 5. Conducting a trial period prior to installing permanent solutions
 - iii. After discussion, Ahearn decided he will rework his suggestions and come back to the Committees with updated suggested plans
 - iv. Uphill bike lanes are planned for Hill Street and Berlin Street
 - v. Suggestion presented: 'WELCOME TO BARRE CITY' signs to notify drivers they are now in a downtown environment
- c. Review/Discussion of Proposed Speed Enforcement Initiative
 - i. DRAFT Concept Proposal shared by City Manager Mackenzie
 - ii. The City Manager, Police Chiefs and Director of Public Works are in the process of collaborating to develop a trial program to address chronic vehicular speeding complaints on some of the more heavily traveled Streets within the City of Barre. This initiative generally consists of the following elements:
 - 1. Delineation of Speed Enforcement Zones on selected problem Streets
 - 2. Installation of high visibility Speed Enforcement Signage
 - 3. Increased deployment of the RADAR Speed Carts within these Zones
 - 4. Increased Speed Enforcement Directed Patrols within the identified Speed Zones.
 - 5. Speed and Citation Data Collection to Monitor the effectiveness of the Enforcement Zones and program.
