1. **Call to order:** 5:35 p.m.

2. **Adjustments to Agenda**: Motions to move SnoBee Agenda item to first order of business (Chris) and add Hunting Season Communication as an Agenda Item (Janette). All in favor motion passes.

3. Agenda Items:

Approval of Minutes- 9-15-2022. Motion moved Janette, 2nd Tim. All in favor -motion passes. SnoBees- Motion (Chris) to use Semprebon Cow Pasture Fund to provide a \$100.00 donation to the SnoBees to cover equipment maintenance for brush-hogging completed in October. 2nd-Janette. All in favor-motion passes. Council approved SnoBees Agreement (Consent Agenda item).
